13 February 2003, EU published Directive 2002/95/EC of the European Parliament and of the Council on the restriction of the use of certain hazardous substances in electrical and electronic equipment.

1 July 2011, THE EUROPEAN PARLIAMENT AND THE COUNCIL OF THE EUROPEAN UNION published DIRECTIVE 2011/65/EU (RoHS 2.0) on Official Journal of the European Union, replacing Directive 2002/95/EC.

There are totally 45 entries in RoHS 2.0 Annex III and 47 entries in Annex IV.

The latest revision was on Feb 24, 2022. The official journal of the European Union issued twelve amended directives on mercury exemption clauses of Annex III of RoHS Directive: (EU) 2022/274, (EU) 2022/275, (EU)2022/276, (EU)2022/277, (EU)2022/278, (EU)2022/279, (EU)2022/280, (EU)2022/281, (EU) 2022/282, (EU) 2022/283, (EU) 2022/284, (EU) 2022/287.
